ADDENDUM TO OPERATIONAL PROCEDURE 113 INMATE MAIL

Effective immediately, the following bolded changes will be incorporated in Operational Procedure (OP) 113, Inmate Mail, regarding the change from 15 days to 30 days an inmate has to respond to the notification that a mail, package or publication has been denied based on Informational Bulletin 15/17.

VII. METHOD

- L. Disposition of Undelivered Contraband Mail
 - d. The inmate will be given a notice advising he has 15-days 30 days from the date of notice advising him that disallowable mail was received at NKSP. The notice will advise him to forward a CDCR-193 Trust Account Withdrawal Order to the mailroom to pay the postage to have the item(s) returned to the sender. The notice shall advise the inmate with a description of the disallowed property/publications, who mailed it, and the reason why the property/mail is not allowed. If the inmate fails to respond within the 15-day period 30-day period, the item(s) will be disposed of by donation of the item(s) to charitable organizations, destroyed if obscene or unusable in the "Hot Trash" receptacle.

This policy will remain in effect until incorporated into the next revision of OP 113, Inmate Mail. If you have any questions regarding this matter, please contact the Custody Captain at extension 7000.
