Reinforce the importance of range safety by everyone on the range.

Firearms group will be split into two groups, one will fire the handgun and the other group will fire the shotgun/handgun course. These groups will rotate and complete each of the above listed courses of fire. After completing weapons training, the morning group will be released for lunch. The morning weapons group will then move to defensive tactics training. The morning defensive tactic group will then move to firearms training. Evening Weapons Proficiency training will not be split into sub-groups. Firearms training will be held first, beginning on "B" range and then "C" range. After firearms training has been completed, the group will be released for lunch. After lunch, the group will report to defensive tactics training.

All range scores will be logged and entered into the range computer.

Any other associated documentation will be completed prior to leaving.

Day and evening scheduled Firearms Instructors will insure the ranges are policed and ready for the next shifts Weapons Proficiency Training.

e. Subjects in custody who have been sprayed with Mace or OC shall have their eyes and face thoroughly washed with clear water as soon as possible.

# G. USE OF LETHAL FORCE:

- 1. Lethal force is the highest level on the "Use of Force Continuum Matrix". Lethal force may be used under the following circumstances when all other appropriate means of defense have failed or are deemed inadequate and the officer taking action has a reasonable belief that such force is necessary:
  - a. As a means of defending oneself from death or the immediate threat of serious bodily injury.
  - b. To defend another person from death or the immediate threat of serious physical injury.
  - c. To apprehend a suspect when there exists a reasonable belief that the person has committed a felony and represents an immediate threat to another human life.
  - d. As a means of terminating dangerous or seriously injured animals when other means of disposal are impractical.
- When officers are engaged in a life threatening situation, the use of makeshift weapons or any weapon of opportunity can be justified as lethal force when reasonable alternatives have been exhausted or appear impractical.
- 3. <u>Use of Motor Vehicle</u>: The use of a motor vehicle to ram or block another vehicle or moving object shall be considered lethal force and may only be used when lesser levels of force have failed or have been determined to be ineffective in addressing the actions of the subject.
- 4. <u>Terms Defined</u>: For the purpose of interpreting the appropriate use of lethal force, the following definitions clarify specific points:
  - a. Reasonable Belief: A strong suspicion based on facts that can be articulated.
  - b. <u>Serious Physical Injury</u>: A physical injury that creates a substantial risk of death, causes serious permanent disfigurement, or may result in long-term loss or impairment of the functioning of any body member or organ.
  - c. Warning Shots: The discharge of a firearm by a peace officer without the intent of striking the suspect or inflicting bodily harm.
- 5. Members are prohibited from firing warning shots in the course of performing their law enforcement responsibilities since they may create a substantial risk of harm to innocent bystanders.

# H. POST INCIDENT ADMINISTRATION OF FIRST AID - ALL LEVELS OF FORCE:

Any subject who is injured as a result of an officer using force shall be administered first aid in the field and/or transported, as soon as possible, via appropriate ambulance or Sheriff's vehicle, to a medical facility for treatment. Special attention shall be paid to the following:

- 1. Officers are prohibited from securing a subject by binding his/her hands and feet together behind the back in a "hog tieing" fashion and/or transporting them on their stomach in a vehicle.
- 2. During field detention, transportation and custodial restraint situations, subjects shall be positioned so that they do not experience breathing difficulty for a prolonged period of time. This is especially important if a subject has been sprayed with OC and/or is suspected of being under the influence of drugs or narcotics. It is critical to closely monitor subjects who are experiencing breathing difficulty and

## I. Use of Lethal Force Policy

- A. Hand out copy of the Use of Force Policy Re: Firearms and O.C. spray.
- B. Reiterate the facts about the "fleeing felon rule."

  The D.A. may or may not charge an officer for shooting.

  The department may take punitive action either way.
  - 1. If there is no immediate threat of serious injury, don't shoot.
  - 2. If you do shoot, situations will be looked at on a case by case basis.
  - 3. Be able to justify your actions verbally and in written form. All physical evidence will be taken into consideration regarding your actions.
  - 4. Cover the use of lethal force for terminating dangerous or seriously injured animals when other means of disposal are impractical.

    Cover weapon selection and optimum target area on a given animal.

# II. Range Safety

- A. Discuss the following topic with class:
  - 1. No live ammunition is allowed in the classroom.
  - 2. Range safety is everyone's responsibility.
  - 3. Importance of keeping your trigger finger outside the trigger guard unless you feel it needs to be there.

    - a. Never point your weapon at anything you're not willing to destroy.
    - b. Know your backstop.
