TO HELP US PROVIDE THE INFORMATION YOU ARE REQUESTING IN A TIMELY MANNER, PLEASE CAREFULLY COMPLETE THE FOLLOWING STEPS:

- 1. PRINT IN ENGLISH AND <u>AS DARKLY AND CLEARLY AS YOU CAN</u>, YOUR NAME, JAIL IDENTIFICATION NUMBER AND HOUSING UNIT SO THAT THE INFORMATION WE SEND WILL BE RETURNED TO YOU AS QUICKLY AS POSSIBLE.
- 2. IF YOU ARE COURT CERTIFIED AS "PRO PER" or "PRO SE" (REPRESENTING YOURSELF) ANSWER "YES" TO THAT QUESTION. IF YOU HAVE A SCHEDULED COURT DATE, PLEASE WRITE THAT DATE IN THE SPACE LABELED "NEXT COURT DATE." PRIORITY IS GIVEN TO REQUESTS MADE BY PRO SE INMATES AND TO CASES WITH IMMEDIATELY APPROACHING COURT DATES.
