CHAPTER: Inmate Services and Programs	SUBJECT: Inmate Entertainment Systems	

- I. **PURPOSE:** To describe inmate entertainment systems in place in Detention and Corrections Division (D&C).
- II. **POLICY:** It shall be the policy of D&C to provide inmates with the opportunity to view and/or listen to select television and video broadcasts while incarcerated. This service shall be provided for inmate recreation and entertainment.
- III. **PROCEDURE:**
 - A. Television sets for inmate use are located throughout the Glenn E. Dyer Detention Facility (GEDDF) and the Santa Rita Jail (SRJ). Electrical power to all housing unit televisions is controlled by housing control and will be turned on during pod time. Closed caption television is available to any inmate by requesting access from the recreation supervisor or his/her designee. Televisions are located in the following areas:
 1. GDJ: Housing floors:
 - a. One (1) per pod.
 - b. One (1) in each day room.
 - c. One (1) per multi-purpose room.
 2. SRJ:
 - a. Outpatient Housing Unit: one (1) in every room
 - b. Maximum-Security Housing Units: one (1) per pod and one (1) per multi-purpose room
 - c. Medium-Security Housing Units: four (4) per housing unit and one (1) per multi-purpose room
 - d. Minimum-Security Housing Units: four (4) per housing unit and one (1) per multi-purpose room. In Housing Unit 31 there is one (1) 50" mounted television in each day room.

B. TELEVISION VIEWING: The D&C has television programming with Direct T.V. Television stations at the SRJ and the GEDDF:

C. VIDEO:

1. GEDDF: The video room is located in the maintenance room annex (fan room) next to the administrative offices and staff dining room.
2. SRJ: The video **system** is located in Inmate Services, and in room #206A located near Control Point 11.
3. Each housing unit television is equipped to receive taped programming. Video time schedules and channel selections are posted in each housing unit. The video system will be used for the following:

- a. Inmate orientation.
 - b. Special programming, such as appropriate informational videos, and religious services.
4. Video schedules are as follows:
1. Inmate orientation: 24- hours per day, in ITR and housing units on channel 27.
 2. Law library information: Monday, Wednesday, and Friday at 0700 hours on channel 10.
 3. Chapel services, Tuesdays, 0800 - 0900, on channel 10.
