SUBJECT: LETTER OF CORRECTIVE ACTION RE: 2016 BIENNIAL BOARD OF STATE COMMUNITY CORRECTIONS INSPECTION

The Board of State Community Corrections (BSCC) conducted its biennial inspection of Santa Rita Jail earlier this year and returned their report November 28, 2016.

In the report, it was noted Santa Rita Jail was non compliant as it pertains to Title 24, Section 470.2.8 (Dormitory washbasins and sinks) and Section 470.3.4 (Showers). The issue of non compliance was the ratio of inmates to the availability of these facilities.

This has been an issue in the past due to the number of bunks in each pod in correspondence to the number of toilets and showers. Due to the decrease in minimum security population, we can now achieve compliance in this standard.

In order to correct this issue, we will be removing a total of 40 beds throughout Housing Unit 34 so there are no more than 20 beds in each pod. This will put us in compliance with the above listed Title 24 sections. Upon completion of the bed removal, inmates from Housing Unit 33 will be moved to Housing Unit 34. Even with the removal of beds, there will be a total of 41 empty beds available for use in Housing Unit 34, based upon today's count.
